# Trader's Terms & Conditions

- Pitches will all be allocated on receipt of the booking form and payment. On arrival you will be escorted to your allocated pitch so please ensure that you check in with the show office on arrival.
- All Trader's must send a copy of their own Public Liability Insurance and valid risk assessment with this application. Please ensure you bring all this documentation with you for inspection.
- The term "Trader" means any person or company who has paid for and occupies a trader's pitch at the Cotswold Air Show over the weekend of 19<sup>th</sup> / 20<sup>th</sup> June 2010 for the purpose of selling goods.
- The Trader fully understands that it is their responsibility to ensure that their pitch will be left clean and all litter and waste will be removed and any damage undertaken to the site during the period of the event will be repaired by the Trader to the satisfaction of a CAS representative.
- The Trader will fully comply with all Health and Safety regulations as set out by the relevant authorities.
- No person shall tamper or interfere with any aircraft or anything used in connection with any aircraft.
- No person shall commit any act causing or tending to cause an outbreak of fire.
- On parts of Cotswold Airport to which the road traffic enactments do not apply, no person shall drive a motor vehicle without due care and attention or without reasonable consideration for other persons using those parts of the Airport.
- No person shall loiter, frequent or remain on Cotswold Airport or any part thereof without reasonable cause.
- No Dogs or Pets will be allowed on the Airport.
- All persons shall at all times whilst on Cotswold Airport wear their official pass and display their security pass clearly within their vehicle.
- No person shall fill or discharge from any container including any part of a vehicle liquid fuel anywhere on Cotswold Airport.
- All Trader's attending both days of the Cotswold Air Show must be on site no later than 20.00hrs on Friday 18<sup>th</sup> June 2010, unless by special arrangement.
- All Trader's attending on Saturday only must be on site no later than 20.00 on Friday 18<sup>th</sup> June. Traders attending on Sunday only must be set up and ready by 08.00 on Sunday 20<sup>th</sup>.
- Payment must be made in advance at least one month prior to the event, with cheques made payable to Kemble Air Services.
- Each pitch represents 5mtrs of frontage and 10mtrs deep.
- Trader's must continue trading until at least 1 hour after the flying display finishes to ease congestion on the exits.
- Please note that no weapons (real or imitation), knives, balloons or kites can be brought onto site to be sold.
